## Data protection policy

### 1. What data is stored

We process personal data which we receive from you as part of our membership in the Förderverein. We also process personal data because you have given us a direct debit authorization. The following data is required for membership:

- First and Last Name
- Address (street, house number, zip code, place of residence)
- E-mail address
- if applicable, number of children at the ISC
- Bank details (IBAN, BIC, name bank, account holder)
- if applicable, tax assessment or proof of income

No personal data is collected from when using the ISC website. The privacy policy of International School Campus - WABE Education Network gGmbH applies therefor.

### 2. Who has access to my data?

Generally your information is stored exclusively in our database, to which only a few people have access. For the execution of the SEPA Direct Debit Scheme, a single person is entrusted with at WABE e.V. - Accounting Department, for which there is a contract processing agreement.

### 3. What is the data needed for?

- The address and telephone number we need for any queries while collecting the membership fee.
- The e-mail addresses are required for paperless delivery of invitations to the meetings and other information of the Förderverein.
- The number of own children at ISC is needed for statistical purposes.
- We require the account data for the collection of the monthly contributions by Sepa direct debit mandate.
- A tax assessment or proof of income may be required to calculate a reduced contribution.

### 4. Do you share my information with third parties?

We generally do not pass personal information to uninvolved third parties. There can also be legal obligations. This is the case when government agencies ask us for information or we receive a court order in this regard, or, for example, due to fiscal retention requirements.

### 5. Where and how is my data stored?

The data is stored encrypted on local data carriers. The backups are also encrypted on local disks. The details of the bank account details are also stored in the account access of the bank for the fulfillment of the SEPA direct debit.

### 6. Can I have my personal data deleted?

Yes, if they are no longer required and there are no other storage requirements, such as tax regulations. The retention period for personal data is 6 years, for invoices / donation certificates 10 years.

### 7. Can I revoke my consent to this Privacy Policy?

As a member of the Förderverein, you must recognize this privacy policy. Of course, you can revoke your consent at any time, but then you cannot continue to be a member of the Förderverein. In case of a revoked consent we will delete your personal data according to the retention periods. Please note that the revocation only works for the future. Processing that occurred before the revocation is not affected.

Legal basis is the consent in connection with Art.6 Abs. 1 DSGVO.
